Since the reinvigoration of the RCM program in 2015, the district is building on these past achievements. Through regular monitoring of the district's energy use and identification of new opportunities since September 2015, the district has saved:

APRIL RESOURCE CONSERVATION MANAGEMENT REPORT

Highline Public Schools is working to maximizing energy efficiency and utility cost across all schools. In 2015, McKinstry began providing additional support for the RCM program, and has been helping identify and implement changes that are building on years of efficiency efforts.

PROGRAM HIGHLIGHTS

- 1. January cost avoidance of over \$29,000.
- 2. Discovered gas meter issue at Cascade Middle School and worked with PSE to resolve issue. Issue results in skewed energy savings percentage for gas and overall energy.
- 3. Electric savings improves 1% to 12%. Natural Gas savings is still positive, but declined to only 2%.
- 4. Recommendations for improvement being tracked in SchoolDude are getting completed or being addressed.






OVERALL DISTRICT PERFORMANCE


