II. WHY BOARD ACTION IS NECESSARY

Projects with contract amounts over \$250,000 or projects which have liens filed against them shall be accepted by the board upon recommendation of the Superintendent.

III. BACKGROUND INFORMATION

On December 5, 2018, the District entered into a contract with Field Turf through King County Director's Association (KCDA) to construct a new turf field where the existing grass football field was located. Field lighting was an alternative to the project and its approval was contingent on additional funds becoming available to the district. The district received grants in the amount of \$700,000 from the NFL Foundation Grassroots Program and King County to replace the grass field with turf and install field lighting.

Field Turf's original purchase order is P190844 in the amount of \$1,362,792.59, not including Washington State sales tax. There were six change orders totaling \$704,201.86, not including Washington State sales tax, for a total contract amount of \$2,066,994.45 not including Washington State sales tax.

The work was completed a couple of years ago but due to Covid and Field Turf's oversight, the district hadn't received the last closeout item which was the final permit for field lighting. King county just issued the final permit, and now Capital Projects staff recommend the board to approve the final acceptance of the Evergreen High School Sports Field Replacement Project.
